### LIABILITIES

1. The Renter is liable for all parking and traffic violations, including an administration fee of R500.00 per traffic offence. The Renter is further responsible for all Toll Fees levied during the rental period.
2. If the Renter wishes to extend the rental period Sahara Down must be contacted 24 hours in advance of the original return date and any additional rental days will be settled immediately and in advance. A R2000.00 penalty is applicable to any and all overdue rentals per overdue period.
3. A Damage / Loss Claim Handling Fee is applicable per incident in the event of any damage or loss to the vehicle.
4. In the event of a Single Vehicle Accident, the renter will be liable for double the chosen excess or the full amount of damages. Please refer to the standard terms and conditions for further information.
5. If an accident occurs; (a) it must be reported immediately to the Company, (b) the details of all persons involved and any witness(es) and the police should be obtained and a sketch plan should be made. You must not make any admission that you were at fault nor make or promise any payment.
6. The vehicle is to be returned with a full fuel tank. should the vehicle need refuelling on return, a refuelling fee of R300 will be charged as well as the fuel filled to the current local price.
